- **1. Proof of Residency:** Verify your CNMI residency with a utility bill, CNMI Driver's License, or government-issued ID.
- **2. Business License:** Include a copy of your current business license to confirm legal registration. (If Applicable)
- **3. Business Plan:** Submit a comprehensive business plan outlining your goals and strategies.
- **4. Tax Clearance:** Provide a tax clearance certificate to show your business is in good standing with local tax authorities.
- **5. Financial Projections:** Share your expected financial performance, including income statements and cash flow forecasts.

Note: When submitting your financial projections, please include a minimum of three (3) vendor quotations for the equipment you intend to acquire, **if applicable.**
